2. develop, advocate, and reward excellence in science learning and teaching practices that contributes to the students' learning experience and outcomes;


3. reinforce the concept of the teaching profession and science education development as a driving force in the regional progress leading collectively to prosperity and peace to the ASEAN Economic Community; and

4. foster cooperation and close relationships among SEAMEO Member Countries by means of better science education and a greater awareness of the place of science in society.

There will be thirty (30) selected teacher nominees to the KHD Award who will be given a scholarship (registration fee, accommodation, meals, and transportation to be shouldered by the organizers).

The awarding ceremony will be held on 17 - 19 September 2018 in Bali, Indonesia during the International Conference on Science Education and Teacher Professional





Development (ICon). This is biennial event of SEAMEO QITEP in Science, where teachers, academics, researchers and education observers gather to inform, discuss, exchange and disseminate their best practices in facilitating the learning process.

LIST OF REQUIREMENTS

A. Qualifications

- a. Filipino citizen
- b. Must have rendered at least two (2) years of service in the government (DepEd) at the time of nomination
- c. Must hold a permanent appointment at the organization nominating him/her
- d. Must have obtained at least a Very Satisfactory performance rating for two (2) consecutive period preceding the nomination
- e. Must have no pending administrative and/or criminal case
- Must have a college degree and/or sufficient demonstrated ability and experience related/relevant to the course applied for
- g. Must have no pending nomination for scholarship in another program/course
- Must have already rendered the required service obligation for a scholarship previously enjoyed
- Must meet the position level, age, education and experience required and specified by the donor country/organization/course
- . Must have a good command of the English language (spoken and written)
- k. Physically and medically fit to travel
- 1. Must have above average ICT skills
- m. Not an expectant mother

B. Documentary

- a. Endorsement from RO and SDO
- b. Detailed and updated Curriculum Vitae
- c. Letter of Application addressed to the donor organization
- d. Nomination Letter from the Regional Director or his/her duly authorized representative (thru the Regional HRDD Chiefs)
- Statement of present actual duties and responsibilities relevant to the course/program, signed by the immediate supervisor
- f. Personal Data Sheet
- g. Service record
- Performance rating for two (2) consecutive rating periods immediately preceding the nomination
- Medical certificate of physical fitness issued by a physician from a recognized accredited health institution but not the same institution where the applicant is presently employed
- Certification that the applicant has no pending application for scholarship under another program signed by the immediate supervisor
- k. Certification of no pending administrative and/or criminal case signed by the applicant's respective legal / administrative officer
- 1. Photocopy of Valid Passport (2 copies)
