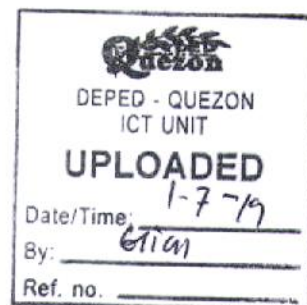

For the presenters:

- a. There must be a five (5) minute video presentation highlighting the context of your project, its implementation, processes and milestones it has achieved so far, as well as significant accomplishments. Such video must be uploaded to this link, **bit.ly/06ILPDDSCOLVID** not later than January 11, 2019 (Friday), 5:00 pm. Video file shall be given filename using the code assigned (see list and schedule above.). *Signing in your deped.gov.ph account is required before you can upload.*
- b. Bring hardcopy of APIP during the day of the colloquium.
- c. **Per each SDO, there must be at least one (1) complete set of equipment such as laptop, portable speaker, USB and set of peripherals** to play the video so as not to experience hassle. The videos may not play when downloaded from different formats. Just to make sure it will not fail. Your video must be **PRE-TESTED** using the compatible computer available during the presentation.
- d. Come in the venue in corporate attire.
