COMPETITION GUIDELINES

- Open to all who won or are selected to represent each district in the Congressional competition. Members should be currently enrolled in the school and level which they represent.
- 2. Each District may participate in only one category (elementary OR high school category).
- To join, the school must submit a filled-out Registration Form with the Official Entry Form.
 Please submit entries to the Congressional Host District through the Cultural Coordinator. Deadline of submission of Entry Form is on ______.
 Deadline of submission of the repertoire and members list is on _____.

 Each band is allowed two (2) pieces of their choice, with choreography; medley is
- Each band is allowed two (2) pieces of their choice, with choreography; medley is allowed, as long as it is within the allotted time.
- 5. The number of participants for each competing band (instrumentalists, flag bearers and majorettes) may have a minimum of
 - Not less than 40 (forty) instrumentalists;
 Instruments may include marimbas, marching lyres and xylophones.
 - b. Flag Bearers and Majorettes are unlimited.
- All the members of the band should do the drill of formation/choreography and not the majorettes and flag bearers alone.
- 7. Playing time for each group must not exceed fifteen (15) minutes, excluding entrance and exit. Judging and time count shall commence from the start of the first beat.
- 8. Participants' attire should be simple, inexpensive and without any identifying marks of the school which they represent. Costumes shall be modest and in decent form.
- All the participating teams must observe safety precaution at all times during the performance.
- 10. Effects, props must not be harmful to the environment.
