DIVISION MEMORANDUM

ADMINISTRATION OF THE ENGLISH PROFICIENCY TEST FOR TEACHER APPLICANTS

To: SGOD and CID Chiefs, Division Testing Coordinator, Public Schools District Supervisors, District Testing Coordinators, School Heads (Elementary & Secondary), All Others Concerned

1. The Department of Education (DepEd) through the Bureau of Education Assessment (BEA), in coordination with the Schools Division Offices will administer the **English Proficiency Test (EPT) for Teacher Applicants** nationwide. The said test will be administered by BEA in 10 batches, starting **September 1, 2019** at **Region IV-A CALABARZON** as the first batch. The result of the EPT shall be valid for **two (2) years** from the time of the test administration.
2. Relative thereto, this office is inviting all qualified and interested applicants to register online at <http://deped.in/2019EPT> not later than **5:00PM** of **August 23, 2019**. Test-takers in 2017 and the previous years who are not yet hired are advised to take the EPT. However, takers for SY 2018-2019 and SY 2019-2020 are no longer required to take the test since their EPT results are still valid.
3. **Division Orientation** for the **Room Examiners, Room Supervisors**, and other **Support Staff** will be on **August 30, 2019, 1:00 PM** at the **SDO Training Center**. A separate Memorandum for the list of qualified examinees, Room Examiners, Room Supervisors, Support Staff and other details will be issued separately upon release of the official DepEd Memorandum by the Central Office.
4. All personnel involved in the administration of the test will be entitled to service credits as per **DepEd Order No. 53, s. 2003** entitled **Updated Guidelines on the Grant of Service Credit to Teachers**.
5. Transportation and other incidental expenses of all concerned during the orientation and administration shall be charged against local funds subject to usual accounting and auditing rules and regulations.
6. **Public Schools District Supervisors** and **School Heads** are requested to disseminate information to all teacher-applicants.

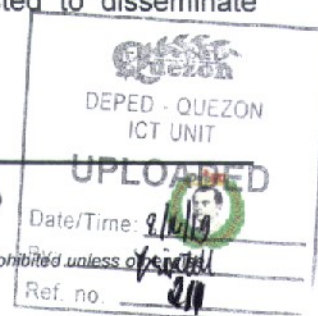
