



DATE : October 1, 2019

1. In line with the RM 19-344 on the 2019 Conference of Basic Education Researchers (2019 CBER), the Regional Office through the Policy Planning and Research Division (PPRD) would like to remind all presenters to register on or before October 10, 2019. An email will be sent to the individual researcher as verification and confirmation of participation. The conference fee is Php5,000.00 per presenter.
2. All payment of registration fees must be made through bank deposit:

3. A research will be presented by a single individual, that individual is the only one entitled for the Certificate of Presentation and Certificate of Appearance. Likewise, should all co-authors of a single research decided to attend the conference as an observer, **EACH** must pay the total amount of registration fee. If they pay in a single deposit (i.e. 3 members x Php 5,000.00 each = Php15,000.00), the names of the group members must be indicated on the scanned deposit slip. They will be entitled to a Certificate of Participation and Certificate of Appearance. For those who submitted multiple research, the researcher must register ones only.
4. Upon payment of registration fee, register to the link bit.ly/2019CBERregistration. Fill in all required information and upload the pdf file of the deposit slip in the portion of the link. This will be the basis of printing the certificates. A copy of your responses in the registration will be emailed to you to be presented during the registration in the venue.

5. All presenters, participants, committee chair, and members must provide a photocopy of the deposit slips to their respective Senior Education Program Specialist (SEPS) for Research. Participants from other Regions must present this to the in-charge during the conference registration at the venue. The SEPS will check if the name/s of the presenters/participants appear in bit.ly view page and will inform the presenter/participant that he/she is an enlisted presenter in the conference. The Planning Officers (POs) in-charge in the issuance of receipts will distribute the receipts at the conference venue. Please present the original copy of the deposit slip as confirmation of payment.
6. Only those participants who registered online **on or before October 10, 2019**, shall be included in the final program, receive conference kits, and meal stubs. And also, the basis for Research Culture Advancement Award (RCAA) as indicated in RM-19-572.
7. All researchers listed in this Memorandum are qualified to submit the full paper for the best paper award which shall be selected based on the indicators suggested in DepEd Order No. 16 s. 2017. The research paper must observe the APA style which has the following components: **Title, Abstract, Introduction** (including Research Questions and a Brief Review of Literature), **Methods** (including research design, sampling, data collection and analysis and ethical issues), **Results, Discussion, Conclusions, References and Acknowledgement** (if any).
