FILING OF APPLICATION FORMS IN PREPARATION **FOR THE QSHSAT (SY 2020-2021)**

To: Public Schools District Supervisors, Public and Private Elementary School Heads, All Others Concerned

1. The DepEd Division of Quezon announces the filing of application forms to screen qualified applicants for the Quezon Science High School Admission Test (QSHSAT) SY 2020-2021.

2. ELIGIBILITY

The guidelines on the eligibility of applicants are as follows:

- a. applicant must be:
 - bonafide resident of Quezon Province, Lucena City and Tayabas City
 - incoming grade 7 student
 - physically and psychologically fit to undergo rigorous academic program
 - have a good aptitude in Science, Mathematics and English
 - have a rating of at least 85% in Science, Mathematics and English during the first and 2nd quarters of the current school year
 - have final rating of 85% and above in all other subjects
 - have a general average of 85% and above
 - have not taken the QSHAT previously.
- b. For an applicant who had already completed Grade 6, the student must satisfy all of the above requirements and have not yet enrolled in Grade 7.
- 3. Application forms are attached in this Memorandum or can be obtained from the office of the Public Schools District Supervisor or at the office of the QSHS OIC - School Principal. Duly accomplished application forms and photocopy of Form 138 and NSO Birth certificate, endorsement and certificate of good moral signed by the principal should be submitted on or before January 6, 2020 at the QSHS Admission Secretariat, Isabang, Tayabas City. Incomplete documents will not be processed.
