- a. for the school-applicants to undergo a conference to be conducted by the Quality Assurance Division or Legal Unit regarding updates, issuances and processes related to private school operation;

- This Order shall also apply to all remaining schools with pending approval of government 3. permit/recognition for School Year 2019-2020. The Quality Assurance Division thru Schools Division Office shall notify the school-applicants with permit/recognition ready for releasing. All other details and steps will be discussed during the conference.
