Immediate dissemination and strict compliance to this Memorandum is earnestly desired.

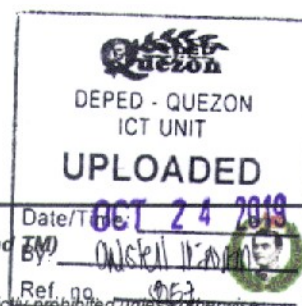
