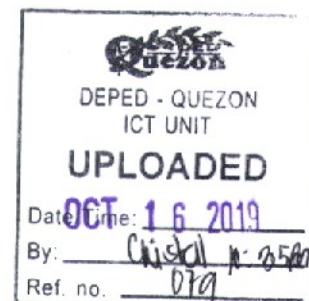

2 -DAY PEAC-CERTIFICATION READINESS TRAINING PROGRAM (PEAC-Cert)

To: All Junior High School ESC Applicants & ESC participating School administrators, principals, school head or JHS coordinators, ESC School coordinators or Registrars

1. The PEAC National Secretariat and the United Private Educational Institutions of Quezon (UPEIQ) will conduct a 2-Day PEAC – Certification Training Program (PEAC-CeRT) on October 30-31, 2019 at the Paul Hall, Sevilla's Farm Resorts and Hotel, Domoit, Lucena City.
2. The training program aims to:
 - a. provide JHS ESC applicant schools and ESC-Participating schools with an in-depth understanding on how to prepare a directed Standards-based School Improvement Plan (SSIP) aligned with the new Certification Assessment Instruments as part of the preparations for (Re) Certification visits, and
 - a. provide information on current issues, memos and advisories concerning ESC Participating Schools.
3. Participants to this training are all Private School Administrators, Principals, School heads or JHS Coordinators, registrars, IT personnel or all concerned school personnel.
4. Registration is limited for first 200 participants only.
