The meeting aims to:

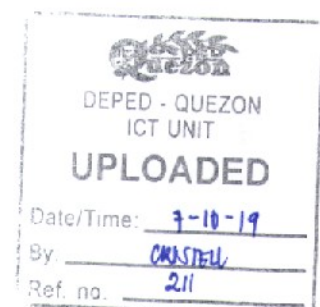
1. orient the school regarding the LIS and EBEIS Requirements for SY 2019-2020;
