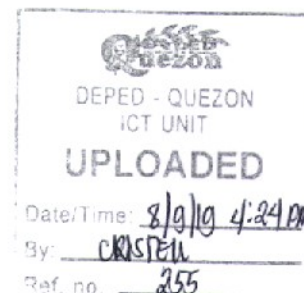

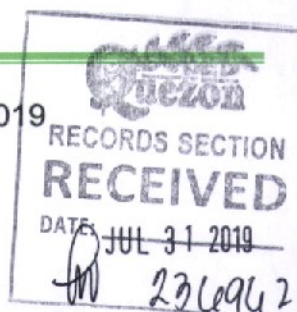

2. **PARTICIPATION REQUIREMENTS:**
 - 2.1 Scouts/Scouters must have attended at least one council-initiated activity (Area-wide or Council Level) to be able to benefit from the **ACTIVITY INCENTIVES and DEVELOPMENTAL EQUIVALENCY in SCOUTING (AIDES)**. However, scouts who don't have lower activity participation can still attend this regional event provided; he will attend future council activities to qualify for the scheme.
 - 2.2 Must be physically fit.
 - 2.3 Scouts must have an accompanying parent/adult.
3. **COORDINATORS CONFERENCE:** All District Kawan Leaders and Kawan Coordinators of Private Schools are advised to attend the meeting on August 21, at the BSP Office, Lucena City to discuss details of participation.
4. All concerned coordinators shall confirm their participation not later than August 16 and must remit the reservation fee of Two Hundred Pesos Only (Php 200.00) not later than August 21; full payment of activity fee must be remitted to the council on or before August 31. Registration after the deadline will not be assured of souvenir items.

1. We are pleased to announce the conduct of the **9th Southern Tagalog Regional KID/KABSAYAHAN** to be hosted by the **Quezon Council, BSP** on **06 - 07 September 2019** with special participation of the KID Scouts, Parents, Langkay Leaders, and Assistant Langkay Leaders.
2. An Activity Fee of Three Hundred Fifty Pesos (PhP 350.00) shall be charged per Scout, Parent and Unit Leader to defray costs of souvenir items, certificates, prizes/awards IDs, supplies, administrative and program needs.
3. **Qualification for Participation:**
 - a. Duly registered KID and KAB Scouts.
 - b. Chief USA (Boy Scout)
 - c. Kawan/Langkay Leaders & Assistant Kawan/Langkay Leaders who are graduates of at least the BTC and are currently registered.
 - d. Parents whose activity fee is highly encouraged.
 - e. Institutional Heads and members of the Institutional Scout Committees.
 - f. Other Scouters of the Council.
4. This activity will feature the following activities:
 - 4.1 Search for the "2019 That's My KAB Scouts"
 - 4.2 Opening/Closing Programs
 - 4.3 KABSayawan Exhibition
 - 4.4 KID/KAB Obstacle Course
 - 4.5 Arts and Crafts
 - 4.6 KID/KABSayahan Games



5. **Attire:** All participating Scouts and Adults are required to be in:
