- 1. Every year, the Synergeia Foundation convenes the **Washington SyCip National Education Summit**. This year, it will be held from September 18 to 19, 2019 at the Philippine International Convention Center, Pasay City.
- The highlights of the summit are the following:
  - a. Proposed study on the management of the Special Education Fund;
  - Conferment of the Seal of Good Education Governance to local government units that have significantly contributed to the increase in participation, retention, and improvement of reading skills of children; and
  - c. Panel discussions on the governance of School Governing Councils: community engagement, making education programs more inclusive.
