- Other Matters

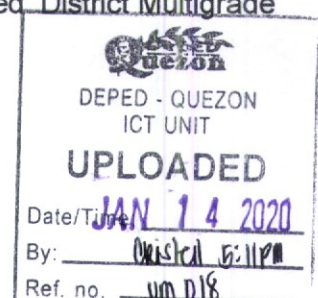
