#### **ECCD Longitudinal Study Round 4 Test Administration**

This has reference to the ongoing ECCD Longitudinal Study on the Effects of ECCD on Learning Experiences and Performance of Kindergarten pupils through Grade 2. The ECCD Study is a four-year research using data on cognitive, social and emotional development, and oral language skills of pupils who enrolled as Kindergarten in SY 2015-2016. Their progress will be monitored until they reach Grade 2 (SY 2017-2018) through four rounds of test administration. Round 1 was completed last September-October 2015, Round 2 was completed last January-March 2016, and Round 3 was completed last January-March 2017.
