

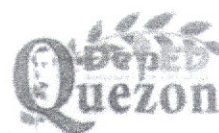

In line with the recently concluded Metrobank-MTAP-DepEd Math Written Elimination, last January 19, 2018 the Division Team Orals (Finals) will be held on February 9, 2018 at Malicboy East Elementary School, Pagbilao, Quezon.

The Top Grade 6 and Grade 10 individuals in the Elimination Round automatically qualify to the Regional Finals. They should have met the hurdle rate of 25 out of 50 or 50% of the perfect score.

First place winners in the Grade 6 and Grade 10 in the division finals are qualified to compete in the Regional Finals provided they meet the hurdle rate of 30 points out of a perfect score of 60.

The participants are advised to be at the venue at 8:00 am. Students must be in their complete uniform.

Necessary arrangement must be made to ensure classes of the participating teachers/coaches, proctors, quizmasters, judges and host schools will not be disrupted. (Instituting Engaged time on Task)

Travel and other expenses relative to the competition may be charged to School MOOE/Local Fund or School MTAP Fund (if any) subject to accounting and auditing rules and regulations.
