

THIS CONTRACT, made and entered into this <u>May 23, 2022</u> by and between the Department of Education, DIVISION OF QUEZON, located at Talipan, Pagbilao, Quezon, represented herein by its Officer In- Charge Office of the Schools Division Superintendent, ELIAS A. ALICAYA JR., Ed.D., hereinafter referred to as the "Owner" of the one part and NENIKO CONSTRUCTION & SUPPLIES represented herein by its Authorized Representative, NENETTE F. ANACION with office address at Brgy. Hagakhakin, Gumaca Quezon hereinafter referred to as the "Contractor" of the other part;

- 6 The Contract Price shall be paid to the Contractor through the Government disbursement procedures subject to the payment, retention money, and warranty provisions in the General Conditions of Contract, the Special Conditions of Contract, and the IRR of RA 9184:
- 7. The Contractor shall pay the Owner for liquidated damages (LD), and not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion of the works for every day of delay. The Owner shall deduct the fiquidated damages from payments or any money due or which may become due the Contractor under this Contract and/or collect such liquidated damages from the retention money or other securities posted by the Contractor whichever is convenient to the Owner. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of this Contract, the Owner shall rescind this Contract, without prejudice to other courses of action and remedies open to the Owner.
