

The Philippine Science Heritage Center (PSHC), under the management of the National Academy of Science and Technology, Philippines (NAST PHL), is mandated by the Republic Act No. 9107 to serve as the main repository of the achievements and contributions of Filipino Scientists to the scientific community. Also known as Salinlahi (heirloom), PSHC is also responsible for promoting Philippine science and technology to the public, specifically the youth.
