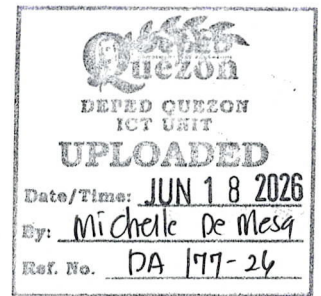


In this connection, we would like to request assistance on the reservation/procurement of accommodation, venue, meals, van rentals, and other expenses needed for the successful conduct of the above activity.
