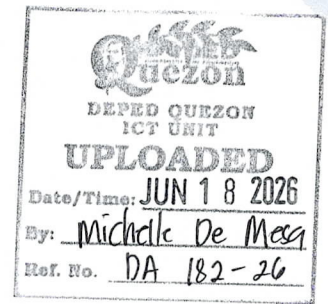

June 23–25, 2026 (Three sessions)
