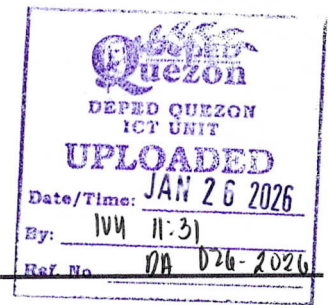

The Multiple Intelligence International School invites public and private junior and senior high school learners nationwide to participate in the Youth Innovation Challenge (YIC) 2026, to be held via Zoom on March 6–7, 2026.

The YIC is an academic platform designed to equip learners with future-ready competencies by engaging them in design thinking, problem-solving, and collaborative dialogue. With this year's theme, I.D.E.A. in the Age of A.I. Leading for Sustainability, YIC empowers Filipino youth to lead sustainable national development by harnessing I.D.E.A. (Inclusion, Diversity, Equity, Anti-Discrimination) principles and emerging artificial intelligence (AI) technologies to address real-world social, environmental, and community challenges.

Specifically, YIC 2026 aims to

- introduce design thinking and I.D.E.A. principles as practical frameworks for capacity-building and nation-building in the age of artificial intelligence;
- equip learners with the mindset and tools to design AI-informed, context-sensitive solutions to pressing social, environmental, and community challenges in the Philippines;
- promote meaningful dialogue that deepens understanding of sustainable development and the responsible use of emerging technologies;
- strengthen learners' 21st-century competencies—communication, collaboration, critical thinking, and creativity (4Cs), to enhance global competitiveness; and
- deepen learners' understanding of their multiple intelligences, providing a platform for skill-building, ethical innovation, and youth leadership toward creating positive and sustainable social impact.
