This office will conduct an orientation on Safety Protocols in the Workplace in accordance with the minimum health standards set by the Department of Health in all sectors. The orientation aims to provide information in ensuring personnel are guided on the implementation of the non- pharmaceutical interventions (NPIs) as minimum public health standards to help in mitigating the threat of COVID-19, be prepared in facing the work scenario and be guided with standards for the new normal in the workplace.

Relevant to this, listed below are the scheduled sessions and participants for the said activity. There will be a two (2) group sessions with a minimum of ten (10) participants as recommended by the IATF, in compliance with the set precautionary measures on physical distancing. All Unit/Section Heads are advised to designate a Safety Officer who will be in-charge for the daily monitoring of each personnel on practices while in the workplace. The participants will be provided with the following knowledge and skills on Infectious Control and Prevention (IPC) for COVID-19 Basic Info on :

- Epidemiology of COVID-19
- Understand the role Infection Prevention and Control (IPC) plays in preventing the spread of COVID-19
- Rational Use of PPE on COVID-19
- Understand the cleaning and disinfection protocols that need to be implemented in all settings

The orientation will be conducted at the Training Center and at the Library Hub. This two (2) sessions will start at 9.00 am- 12 in the morning and at 1:00 - 4:00 in the afternoon on May 22-29 2020 It is expected that all participants shall observed the precautionary measures such as physical distancing and wearing of face mask.
