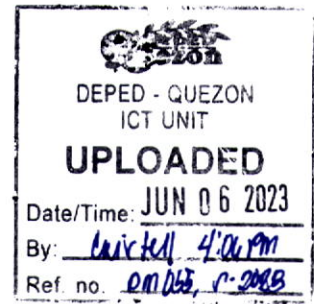

**INTERNATIONAL WEBINAR CONFERENCE AND DEMO TEACHING**



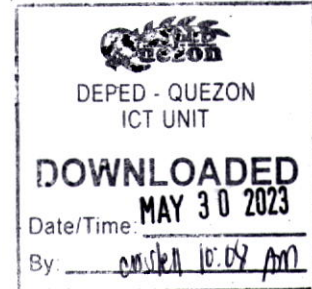
