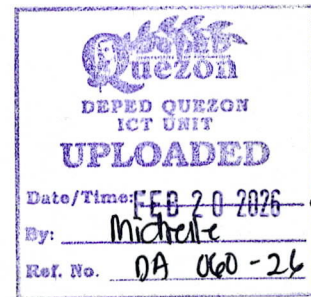

With the theme, *Breaking Barriers: Sustaining Digital Partnerships for Innovative School Libraries*, the three-day Conference aims to support professional and non-professional librarians in public and private school libraries by enabling them to

1. strengthen collaboration between school and public librarians through a shared vision, common goals, and co-designed literacy and learning programs aligned with school curricula and public library outreach;
2. enhance inclusive access to library resources and services by expanding resource sharing beyond physical spaces through digital collections, shared facilities, technical expertise, and innovative technologies that address the needs of diverse and underserved learners; and
3. advance digital innovation and literacy across library environments by integrating technology-driven programs, prompt engineering, and shared platforms that connect learners and promote engagement and reading proficiency.
