


School Nutri-Tour Registration Process


1a. Choose whether you would like to have the program online or on-ground.



Note: On-ground (Face-to-Face) implementation is currently only open for schools located in CALABARZON and Greater Manila Area unless agreed otherwise. We will also only be opening face-to-face events for schools with a greater than 100 students population.

1b. Choose your preferred schedule.


We will try to match your preferred schedule but preferred date is not guaranteed.

We are only conducting a maximum of 3 schools per day (2 morning schedule, 1 afternoon schedule) unless otherwise agreed upon.

1c. Provide contact details of the contact person.



Make sure to include a preferred time for an online meeting with our program coordinator. Follow the format below. Meetings are typically scheduled on Monday unless otherwise agreed.



- 2. Wait for a call/message from our program coordinator for further inquiries regarding your submission. This may come up to 1 week from the date of submission of form. If you did not receive any follow-ups, it's either:
 - a. We did not receive your form.
 - b. We are still looking for other schools within your area. We will only be contacting once we have a prospect date on when we will be conducting the program.

Feel free to contact us if you have not received any follow-up or confirmation.

3. Wait for confirmation email. No confirmation email = no event on your preferred date. We will only be confirming the schedule if we have at least 2 schools booked on the same date. Please do not announce events unless otherwise confirmed.

If you wish to have faster confirmation, you may recommend other schools within your area to our team or invite them yourselves. You may share our registration form with them.
