






#### LOGLINE

In the summer of April, two people met in an unfortunate situation. As they navigate through mishaps and stumble across unexpected common ground in the small town of San Nuesco, their journey becomes a heartwarming exploration of self-discovery and the growth of unlikely connections.

#### **SYNOPSIS**

"Panag-araw" tells a story in the small town of San Nuesco, following Christopher Jr./ Toph driving his car while reflecting on recent family misunderstandings. Frustrated, he discovers his dead father, Topher, has a broken camcorder in the trunk and decides to take it with him.

Walking through San Nuesco, the camcorder miraculously works. Toph encounters Issa, and they head towards Lolo Sergio's house, Topher's grandfather. The scene intertwines with his mother, Isabel, anxious attempts to reach Toph.

The next morning, Issa suggests exploring the town together. They noticed that Toph's belongings were missing, and only his father's box remained. Later on, Issa and Toph share personal stories, fostering a connection. Toph interferes in a confrontation involving a gang and a boy named Caloy, in which he befriends later on in the story. Issa treats Toph's injuries, leading to an invitation for an outing on Saturday. The group embarked on an outing to Ilog Kuwet at San Nuesco. They enjoy various activities, and share fun moments together.

The story takes an emotional turn, revealing that Toph's father, Topher, had recorded video messages for Isabel and Toph. Toph realised that during his stay in San Nuesco, he was actually in his father's consciousness the whole time, then met the younger version of his mom, Issa, in 2001. These serve as a connection between the past and the present. As Isabel reads Topher's letters, expressing love, gratitude, and a promise to return to San Nuesco. Toph discovers the truth about his father's love and the importance of family bonds.

Toph, now back to 2024, rushes to fix a broken camera, only to find a series of video memos recorded by his father. These recordings bring forth memories of the summer of 2001. Toph arrives at Isabel's house to celebrate her birthday, both reconciling their mother and son relationship.

The story concludes with Isabel and Toph heading to San Nuesco to visit Lolo Joselito. The reunion with Caloy, Marie, and Lolo Joselito brings a sense of warmth and belonging, closing the story.

(Short Film Competition)

#### THE COMPETITION

The STI Lucena Film Festival offers an exciting opportunity for students to come together and unleash their creativity through the medium of film.

This collaborative competition encourages teams to craft compelling narratives that reflect their unique perspectives on a designated theme. As participants dive into the world of filmmaking, they not only showcase their talents but also ignite a passion for storytelling. Through this event, we aim to cultivate a community where young filmmakers can thrive, inspire, and celebrate the art of cinematic storytelling.

#### **OBJECTIVES**

Throughout their competition experience, students are expected to:

- 1. Demonstrate creativity as they explore different styles, vignettes, or contexts in the presentation of their novel concept;
- 2. Practice critical thinking, effective communication, and teamwork as they collaborate to come up with a well-crafted video guided by the competition rules and mechanics;
- Exhibit responsibility, sportsmanship, and respect for all aspects of the competition by adhering to the mechanics, rulings of the organizing committee, and acceptance of the outcome of the competition with or without the guidance of peers, coaches, or event organizers;

#### THE CONCEPT

STI Lucena BMMA Short Film Festival 2024 presents "MANIWALA," a theme that encapsulates the essence of belief, trust, and faith. This theme invites filmmakers to explore the profound journey of self-discovery and resilience through their creative vision. "MANIWALA" challenges participants to delve into the depths of human experience, portraying the transformative power of belief in overcoming life's obstacles and making a positive impact.

#### **MECHANICS**

- Participants are encouraged to interpret the theme "MANIWALA" in their own unique and imaginative way. There are no specific guidelines or limitations, allowing for a diverse range of creative expressions.
- 2. The participants must be officially enrolled Senior High School (SHS) and College

#### **JUDGING CRITERIA**

EDITING  The technical execution of special effects, cutting, fading, and the relationship of images to the music: This includes how special effects enhance or detract from the video.	0-15 points
CINEMATOGRAPHY  The overall quality of the visual components including framing of shots, camera angles, and movements	0-15 points
ORIGINALITY  Employment of unique and authentic visual components to express the team's vision	0-20 points
CREATIVITY Imaginative and innovative presentation of the video	0-20 points
CONCEPT INTERPRETATION  Clarity of the team's vision of the concept: It includes the mood and atmosphere created by the audio and visual selections and the visceral impact it has on the viewer.	0-30 points

#### **GENERAL PROVISIONS**

- 1. By submitting one's video, competing teams agree to the rules of the competition.
- 2. Competing teams are responsible for securing formal permissions in the use of borrowed components (i.e., songs, images, or videos).
- Submitted entries shall be the property of the STI Education Services Group, Inc. (STI ESG). Consequently, STI LUCENA reserves the right to feature, reproduce, and promote the videos.
- 4. Entries will be evaluated "as is" for the competition.
- Winners shall receive due recognition and prizes P10000 (Best Film), P5000 (2nd Best Film), P3000 (3rd Best Film) with plaques and certificates.
- 6. The method for awarding winners is yet to be determined, but it is anticipated to take place in Lucena City, Quezon.

#### FILM FESTIVAL 2024

- Interested students must form a team consisting of three to five (3-5) members to represent their school and register at (link) under STI College Lucena. Each school may submit multiple entries.
- 4. Teams must create a video based on their interpretation of the provided concept.
- 5. The Short Film must be accompanied by English subtitles in cases where languages other than Tagalog and English are utilized by the filmmaking team.
- 6. The participants shall submit their Short Film before the deadline (May 20,2024) with their official poster for the Short Film Competition.
- 7. Any of the following shall cause the team's disqualification from the competition:
  - a. The entry is a replica or recreation of any video;
  - b. The entry is not an original creation of the team; and
  - c. The entry contains material that is damaging to the name of School as an academic institution: This includes material that is perceived as discriminatory, offensive, sexually explicit, and unlawful.

#### Submitted entries shall adhere to the following:

a. Total Video Length: Minin

Non-adherence in any of the categories shall result in a five-point deduction from the judge's total scores.

- 8. In case of a tie, the scores of the Chairman of the BOJ shall determine the winner. If the scores of the Chairman of the BOJ are still tied, the Chairman of the BOJ will break the tie.
- 9. The Board of Judges' decision is final and irrevocable.
- 10. The entries will undergo a preliminary screening process (DATE) prior to its official presentation during the showings.
