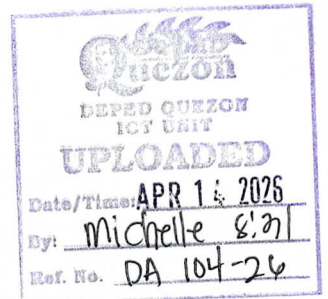

## DEVELOPMENTAL SOCIAL ENTERPRISE AWARD



The **Developmental Social Enterprise Awards (DSEA)** recognizes developing, impactful, and viable organizations whose operations integrate the cost of their social objectives. The Awardee/s have businesses or organizations that have a culture centered on human value, development, and may range from cottage up to medium-sized enterprises with a maximum asset cap of PhP 100 million.

### CRITERIA

1. The Developmental Social Entrepreneur must have a prior commitment to a particular social objective that has consistently existed over the life of the business, particularly the immediate last 5 years (this must include the start-up period).
2. The Social Objective must be integrated in its cost of doing business or cost of goods/services.
3. Social Objective must be significant, consistent and well-defined.
4. The Social Objective's results must be measurable.
5. The DSE must be profitable for at least two (2) years.
6. The DSE has a sustainable and continuous source of cash flow and is profitable after interest and taxes.
7. The DSE must have CSR as part of its Social Enterprise definition

Nominations can be for an individual, team/group, organization, business or, not-for-profit-owned business.

### DOCUMENTATION

1. Submitted nomination forms and supports must be under oath and notarized.
2. Financials must be audited by a CPA.
3. Organizations/businesses must be registered/operating in good order for at least 2 years with all statutory bodies e.g. SEC, DOLE, Mayor's/Barangay Office, etc.
4. A 5-minute (minimum) or longer video must be submitted summarizing the reasons why the individual or organization believe they should be considered for the DSEA.

### Is there a cost to the nomination?

There is no cost involved for nominations.

**If I have won, been a finalist, or were previously nominated in the DSEA (or any of the other BCYF Awards i.e. BIA, CSRYA, and S4HH) in a previous year, can I still nominate myself/my team/my organization/business in this year's award?**

All previous nominees can reapply and be considered nominees and all previous finalists are considered as semi-finalists for the current award.

**If an organization/business has won an Award already under another award-giving body, can I still nominate that organization/business in the DSEA?**

Yes, as long as it meets the requirements set by the DSEA Permanent Committee.

**What will happen to the requirements/materials submitted to the BCYF Secretariat (BCYF-SABRE) after the Awards period?**

The BCYF DSEA own the rights to all materials/requirements that will be submitted. They will not be returned. They may also be disposed of.

# THE AWARD PROCESS

The following flowchart details the award process which all nominees in the Developmental Social Enterprise Award, as well as other recognition programs of BCYF, must undergo.

**1**

The DSEA Committee will accept and review submitted nominations. This committee receives nominations, or add its own nominees.

**2**

From this, the DSEA Committee will interview the nominees then decide who will be the Finalists, and recommend who will be the Awardee/s.

**3**

The BCYF Board of Trustees will review the recommendation from the DSEA Committee, and decide who shall be the Awardee/s.
