 In line with the current thrust of the BSP by giving emphasis on providing quality trainings to our Adults in Scouting during this time of pandemic, the Southern Tagalog Region, BSP is cordially inviting the field to the conduct of COURSE FOR MANAGERS OF LEARNING (CML) on October 19-24, 2021 at ZOOM (Virtual).

Course Description: CML is the First stage in a 2-stage progressive scheme of training trainers; a 6-day (first three (3) days Virtual and last three (3) days on-site Training) course focusing on the role of the trainer as manager of training courses. This course requires a remote/virtual training modality.

This Course offers the two (2) Educational Modalities such as Online and Limited Face to Face in compliance with the IATF Protocols. The first part, will be manage in Virtual Modality while the remaining half of the course will be on Limited Face to Face for Practicum and other topics related which needs Trainers-Trainee Face to Face. This is first come, first serve basis training course. Heath Personnel Team will be available specifically in the limited face to face modality schedules.

2. Qualifications:

- a.) Must be a Two-Beads Holder (with Wood Badge Parchment Certificate) for at least 24 months.
- b.) Should be a registered Unit Leader of the BSP.
- c.) Should have completed Covid vaccine doses (vaccination card is required).
- d.) Should be physically, mentally and medically fit (medical certificate is required).
- 3. A Registration Fee of Five Thousand and Five Hundred Pesos (P5,500.00) shall be charged from each participant to defray the cost of meals, snacks and accommodation (for Participants and Course Staff) souvenir, handouts, training supplies/materials, health kit and other related administrative and program expenses.

Registration Fee, transportation and other incidental expenses related thereof are chargeable against local funds or MOOE subject to its availability with the prescribed accounting and auditing rules and regulations.

- The conduct of these Adult Leaders' Advanced Courses are aimed to provide Leadership Training skills for Kawan Leaders, Troop Leaders, Outfit Advisor, Leaders of Adult, Members of the Training Team, as well as District and Council Leaders and Professionals.
- This present-day training program focuses on leadership and "people" skills which will provide opportunities for the participants to:
 - Learn contemporary leadership concepts and techniques;
 - b. Make them better leaders;
 - Acquire competency for active learning process in planning, development, presentation, and assessment.
- Training Fee: PhP 8,000.00 shall be charged each participant for meals, training materials; administrative budgetary requirements; rentals, camp fees, and other program needs.

6.2 Duly accomplished Application to Attend the Training Course; and

- 6.3 Medical/ Health Certificate showing that the participant has already been injected with the Anti - Covid 19 Vaccine as certified by a licensed physician.
- Schedule: All participants are expected to be at the training venue in time for dinner of the day before the start of the training course and leave for home after the closing ceremonies on the last day.
- 8. Training needs: All participants are requested to come ready with the following:
 - 8.1 At least two (2) sets of type 'A' Scouters uniform (shorts pants for male TLs; skirts/shorts for females)
 - 8.2 Considering that this is a face to face training event with personal interaction with the staff members and participants, all are required to bring sufficient face masks and face shields;
 - 8.3 Enough civilian clothes for: daily wear, activities, games, casual attire for special occasion, sleeping gears, poncho, camera, laptop, references, maintenance medicines, adequate cash for incidental needs, etc.
 - 8.4 Portable tents with ground cloth and tent fly; handy camp tools; flashlight, etc.
 - 8.5 Other personal and optional needs.
- 8. Graduates of the CMT and/or Assistant Leader Trainers desiring to earn credits for their requirements are welcome to assist provided they are duly recommended by the CSE whose council has candidates for the training. Attached hereto is the tentative list of the Staff Members of the different training events for your ready reference. Relative thereto, a Staff Meeting is called for to be held at the Langcauan Hall, MNSR, Los Baños, Laguna on 30 March 2021 at 10:00 A.M. However, the members of the staff will depend upon the number of participants, thus a final list will be released in a separate memorandum.
- Expenses that may be incurred in connection with these training events are chargeable against MOOE and other available local funds subject to the usual accounting, budgeting and auditing procedures, rules and regulations.
