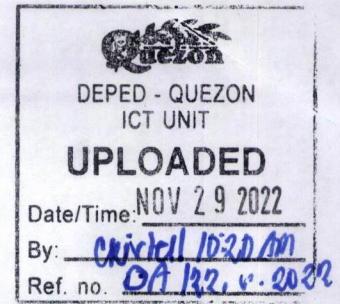

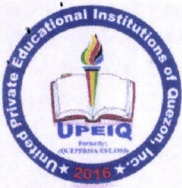

To: UPEIQ MEMBER SCHOOLS

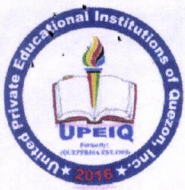


