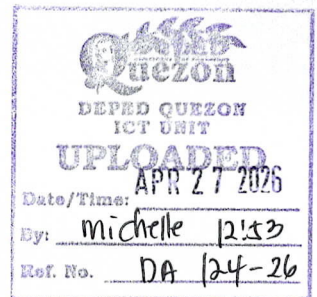



### **National Seminar Workshop on Values Education, GMRC and Edukasyon Sa Pagpapakatao (EsP)**

Theme: Building Character for a Sustainable Future

**Seminar Description:** This seminar highlights the critical role of character education in achieving sustainable development, in alignment with current priorities of the Department of Education and the implementation of Republic Act No. 11476, also known as the GMRC and Values Education Act. This law emphasizes the formation of learners who embody core Filipino values such as Maka-Diyos, Makatao, Makakalikasan, at Makabansa, which are essential in building responsible and future-ready citizens.

Anchored on the MATATAG Curriculum reforms and the Basic Education Development Plan (BEDP 2030), the seminar underscores the importance of integrating values formation, social responsibility, and environmental consciousness into everyday teaching practices. These reforms aim to develop learners who are not only academically competent but also morally grounded, socially responsible, and capable of contributing to nation-building and sustainable communities. Participants will explore experiential and learner-centered approaches in teaching GMRC, Values Education, and Edukasyon sa Pagpapakatao, including reflective activities, real-life applications, and community-based learning.
