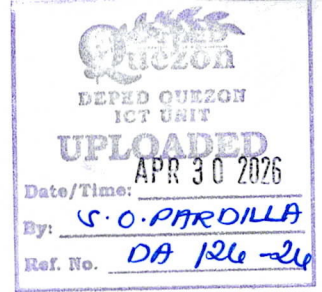

This aligns with the provisions of DepEd Order No. 012, s. 2025, titled "Multi-Year Implementing Guidelines on the School Calendar and Activities," as well as DepEd Order No. 9, s. 2005, titled "Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith." Furthermore, any off-campus activities must adhere to the guidelines specified in DepEd Order No. 66, s. 2017.
