DECONTAMINATION/DISINFECTION OF SCHOOLS DIVISION OFFICE – PAGBILAO, QUEZON

To ensure the safety and well-being of the employees and stakeholders, notice is hereby given to the public that the Schools Division of Quezon through the initiative of SDO Quezon Administrative/General Services Section and SDO DRRM will conduct **Disinfection and Decontamination of Workplace on September 24, 2021 (Friday), at 8 o' clock in the morning.**

This Office emphasizes its policy that DISINFECTION AND DECONTAMINATION OF WORKPLACE must be done twice a month, as part of our Safety Measure during the period of State of Emergency due to Pandemic. This shall include the cleaning and disinfection of every unit, office equipment, and other facilities following the standard enunciated in the existing protocols and guidelines. For business continuity, the Records Section (DIVISION OFFICE) and Sub-Office (GUMACA, QUEZON) are in full operation while others are in Work from Home Arrangement.

Furthermore, DepEd Quezon Sub-Offices in Catanauan Central School, Catanauan, Quezon and Real Central School, Real Quezon, with soft opening on September 28, 2021, and October 5, 2021, as stated in Division Memorandum 687, s.2021 will be on full operational.

In addition, attached herewith the Office of the Governor of Quezon Province issued an Executive Order No. 40 S, 2021, an order adjusting the Omnibus Guidelines of the National IATF – MEID for Areas Placed Under General Community Quarantine (GCQ) with Heightened Restrictions and Implementing Other Adjusted Quarantine Measures within the Province of Quezon. Hereto attached is the copy of the said Executive Order.

EXECUTIVE ORDER NO. 40

Series of 2021

AN ORDER EXTENDING THE IMPLEMENTATION OF GENERAL COMMUNITY QUARANTINE WITH HEIGHTENED RESTRICTIONS IN THE PROVINCE OF QUEZON UNTIL SEPTEMBER 30, 2021.

WHEREAS, on September 16, 2020, the President issued Proclamation No. 1021 (s.2020) extending the period of the State of Calamity throughout the Philippines due to Coronavirus Disease 2019 declared under Proclamation No. 929 (s.2020);

WHEREAS, on September 6, 2021, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases issued Resolution No. 136-F, Series of 2021, extending the imposition of General Community Quarantine with heightened restrictions (GCQ +) in the Province of Quezon, while Lucena City remains to be under Modified Enhanced Community Quarantine (MECQ)until September 30, 2021;

WHEREAS, as of September 7, 2021, 10:00 AM, Quezon Province has recorded a total of 21,189 COVID-19 confirmed patients, 2,114 of which are active cases, 9,279 suspected and 25 probable cases, with 1,023 mortalities and 18,052 recoveries;

WHEREAS, Governor Danilo E. Suarez issued Executive Order No. 33, series of 2021, dated August 6, 2021, setting forth the guidelines for the implementation of GCQ with heightened restrictions in the province, while on May 15, 2020, the Sangguniang Panlalawigan passed a Provincial Ordinance No. 2020-002, series of 2020, which provided for the penalties for violation of public health standards enumerated thereat;

WHEREAS, IATF Resolution No. 136-F dated September 6, 2021 reiterates the guidelines for areas under General Community Quarantine with Heightened Restrictions.

NOW, THEREFORE, I, DANILO E. SUAREZ, Governor of the Province of Quezon, by virtue of the powers vested in me by the Local Government Code and other pertinent laws, do hereby order the following:

SECTION 1. GENERAL COMMUNITY QUARANTINE WITH HEIGHTENED RESTRICTIONS. The Province of Quezon shall remain under GENERAL COMMUNITY QUARANTINE WITH HEIGHTENED RESTRICTIONS (GCQ+) until 11:59 PM, September 30, 2021.

SECTION 2. GUIDELINES. The Guidelines set forth in Executive Order No. 33 series of 2021 entitled "AN ORDER ESTABLISHING GUIDELINES ON THE IMPLEMENTATION OF GENERAL COMMUNITY QUARANTINE WITH HEIGHTENED RESTRICTIONS IN THE PROVINCE OF QUEZON, FROM AUGUST 6 TO 15, 2021" issued on August 6, 2021, shall **remain in force and effect** and shall be observed accordingly by all Local Chief Executives and Barangay Officials within the Province of Quezon.

LCEs are encouraged to issue applicable ordinances and/or additional guidelines, as may be needed.

SECTION 3. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, other provisions not affected thereby shall remain valid and subsisting.

SECTION 4. REPEALING CLAUSE. Executive Orders, rules and regulations or parts thereof, which are inconsistent or in conflict with the provisions of this Order, are hereby repealed or modified accordingly.

SECTION 5. The above provisions shall be subject to daily monitoring and re-assessment by the Quezon COVID-19 Provincial Inter-Agency Task Force, and shall be in accordance with the proclamations of the Inter-Agency Task Force on Emerging Infectious Disease (IATF-EID) and national agencies.

SECTION 6. This Order shall take effect immediately.
