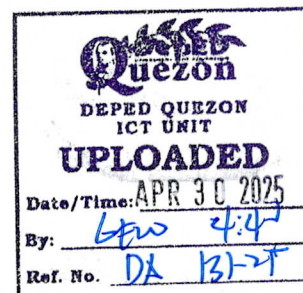

Learners, roboticists, coaches, and teachers are encouraged to participate in the events outlined in the attached advisory. However, participation by learners and teachers from both public and private schools is strictly voluntary and must not disrupt instructional time.

This policy is in accordance with the provisions of DepEd Order No. 009, s. 2024, titled *"Implementing Guidelines on the School Calendar and Activities for the School Year 2024–2025,"* and DepEd Order No. 9, s. 2005, titled *"Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith."*
