

The Global Citizenship Education (GCED) Cooperation Center Philippines, in collaboration with Pangasinan State University, Regional Hub in Region I, will convene the GCC Regional Hubs Summit 2025, with the theme Promoting Cultures, Connecting Minds, Transforming Futures: Advancing GCED through Whole School Approach (WSA), to be held at the Golden Lion Hotel, Pangasinan State University Lingayen Campus, on July 23–25, 2025.

The Summit theme seeks to foster meaningful dialogue, strengthen regional and institutional collaboration, and explore innovative strategies for integrating GCED and Education for Sustainable Development into educational frameworks. It specifically aims to
