

Additionally, recent class and government work suspensions due to tropical cyclones affecting various regions have impacted timely submission of the eIPCRF of teachers.


In view of these, the deadline for uploading the accomplished eIPCRF of teachers for SY 2024–2025 is hereby extended until **September 30, 2025**.
