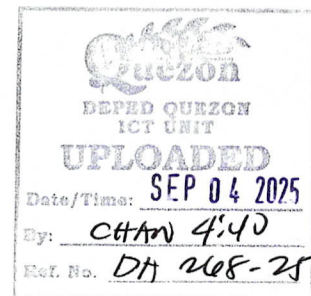

Title	Description

Juan Luna	A musical about the life of Juan Luna and his struggle with mental illness.
Bathaluman	An action-thriller film with Filipino cultural fantasy.
Katips: The Movie	A musical film about the life of the Filipino people in the 1970s, showcasing the young people's desire to effect change in society during the era.
