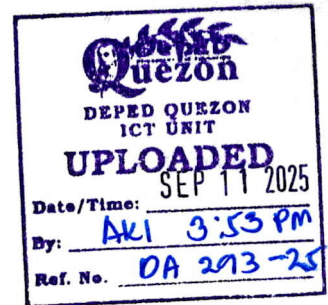


PHILIPPINE ROBOTICS CUP OF CREOTEC PHILIPPINES INC.

PHILIPPINE ROBOTICS CUP OF CREOTEC PHILIPPINES INC.

Creotec Philippines Inc., which has been actively promoting robotics education through its annual competitions since 2018, will launch the Philippine Robotics Cup on October 23, 2025, tentatively at SM South Mall in Las Piñas City.

The event will feature competitions in Line Tracing, Sumobot, Mission-Based Roboventure, On-the-Spot Assembly & Coding, and the 2nd Drone Soccer Competition. The highlight will be the national selection of teams that will represent the Philippines in the World MakeX Robotics Competition.

For the first time, the competition will include an open platform category, enabling participants to use any robot kit brand. All missions are aligned with the United Nations Sustainable Development Goal No. 12–Responsible Production and Consumption, encouraging learners to integrate technical expertise with awareness of global challenges.

To prepare schools and mentors, orientation sessions for robotics coaches will be conducted on the following dates:

- September 5, 2025
- September 19, 2025
