

Abstract Submission Guidelines

- The maximum word count for an abstract proposal is 350. Use the <u>official template</u> for the abstract submission.
- The abstract must include the following important elements: (1) research gap, objectives, and/or questions, (2) methodology, (3) summary of results or claims, and (4) findings' implications.
- All abstract submissions will be evaluated using a double-blind review procedure. The review will
 look at the clarity of content, soundness of the methodology, scientific rigor, and relevance to the
 theme.
- Authors are required to adhere to the style and guidelines of the <u>American Psychological Association</u>
 (APA, 7th Edition).
- The review committee will reserve the right to decide on accepting submitted abstracts. Failure to follow the prescribed template will automatically disqualify the manuscript.
- No part of the manuscript must contain identifying information about the authors (e.g., names, affiliations, acknowledgments).
- Authors may also submit their full papers for publication in the Summit Proceedings. Further details
 will only be sent to the authors with accepted manuscripts. Selected papers will also have an
 opportunity to be published in the Summit's partner journal.
