

UPCOMING WORKSHOPS OF THE AG-BEA TALENT AGENCY

The AG-BEA Talent Agency invites learners to participate in its upcoming workshops in acting, dancing, modeling, and voice, which will be held in various locations across the country. These workshops are designed to support teachers and parents in guiding learners toward developing discipline and building self-confidence.

The overall objectives of the workshops are as follows:

1. Skill Development: Develop basic skills in acting, dancing, modeling, and voice;
2. Confidence Enhancement: Build confidence and self-expression through performance-based activities; and
3. Creativity and Teamwork: Foster creativity, teamwork, and problem-solving skills.
