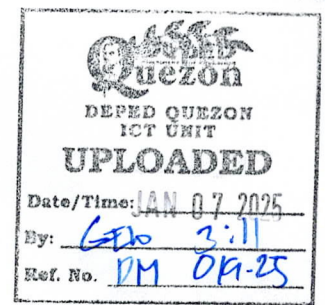

PALARONG QUEZON 2025 SCHEDULE OF ACTIVITIES, HOST VENUES, TECHNICAL OFFICIALS, TECHNICAL WORKING GROUP, AND OFFICIATING OFFICIALS

1. In line with the conduct of the Division Athletic Association Meet dubbed as Palarong Quezon on January 11-18, 2025, this Office provides the hereto attached schedule of activities, host venues, list and assignments of Technical Officials, Members of the Technical Working Group, and Officiating Officials.
2. Hauling of supplies and equipment to the assigned playing venues shall be done on January 7-10, 2025, to be facilitated by the Committees on Hauling, Transportation, and Supplies headed by supply Officer George Aguila. These shall be received by the District Sports Event Coordinators on the said schedule.
3. Please refer to the Division Memorandum No. 882, s. 2024 and Division Memorandum No. 1091, s. 2024 for other details of Palarong Quezon 2025. There will be a simple opening program for the host playing venues in Pagbilao, Quezon National High School, Tiaong and San Antonio on January 12, 2025, after the Solidarity Meeting.
4. The Palarong Quezon 2025 Grand Opening Program shall be held at the Paaralang Elementarya ng Lucban I, Lucban, Quezon on January 13, 2025. To ensure proper space management, only a maximum of 100 members per delegation will be allowed to join the parade and opening program.

5. A welcome and fellowship night will be held at the Batis Aramin Resort and Hotel in Lucban, Quezon, on January 13, 2025, at 7:00 p.m. Each district is allowed to have up to ten attendees, including representatives from their municipal local government.
6. Awarding of winners shall be done in their respective playing venue immediately after the championship. List of winning athletes for individual, dual events, and team events shall be submitted by the Tournament Directors for Selection Overall winner shall be announced in the Closing Program as soon as team standing shall be completed.
7. A safety officer and a nurse or dentist shall be included in each municipality's delegation for medical and security services. Activities relative to the preparation and conduct of activity shall abide to the provisions of DepEd Order No. 9, s. 2005 titled "Instituting Measures to Increase Engaged Time-on-Task" and DepEd Order No. 09, 2024 titled "Implementing Guidelines on the School Calendar and Activities for the School Year 2024-2025" particularly in the prevention of disruption of classes.
8. All teachers who will serve as TWG, officials, coaches and trainers during the selection, screening, training, school/district, division and higher level competition day/s that will fall on either holidays or weekends shall be entitled to **service credits** in accordance to DO No. 53, s. 2003 "Granting of Vacation Service Credits to Teachers", whereas for non-teaching and teaching related personnel **compensatory time-off (CTO)** shall be granted in accordance with the CSC and DBM Joint Circular No.2, s. 2004.
9. The technical officials, technical working group and officiating officials' travel expenses and other incidental expenses not covered by the provincial SEF, shall be charged against LGU SEF, MOOE or local funds, and other sources. The municipal delegation shall provide food for the officiating officials during their service from January 14-18, 2025.
10. Immediate dissemination and compliance of this Memorandum is desired.
