

2026 NATIONAL SCHOOL DEWORMING MONTH

To: Assistant Schools Division Superintendent
 Division Chiefs
 Public Schools District Supervisors
 Elementary and Secondary School Heads
 School Health Personnel
 All Others Concerned

1. In reference to **DepEd Memorandum Nos. 80 and 156, s. 2015**, entitled **“Guidelines On the Implementation of the National Deworming,”** the July (1st Round) and January (2nd Round) of every school year are designated as deworming months.

2. However, deworming activity can also be done on any day of the following months:

July – September 2026	1st Round
January – March 2026	2nd Round

3. In line with this, all enrolled public school learners from Kindergarten to Grade 12, including those in the SNED and ALS, are advised to participate in the said deworming activity.

4. The school nurse shall coordinate with the Local Government Unit (LGU)/ Rural Health Unit (RHU) regarding the additional provision of albendazole tablets, as well as the monitoring and referral of any adverse effects.

5. Be advised that the **District Deworming Activity Report** shall be submitted by the District Nurses to the **Integrated Helminthiasis Control Program Coordinator** on or before April 10, 2026, for the Second Round, and October 9, 2026, for the First Round.
