

**DISSEMINATION OF QUEZON LEARNER RIGHTS AND PROTECTION HELPLINE
LINK AND QR CODE**

1. In line with the mandate to uphold and protect the rights of learners, and to ensure accessible reporting mechanisms within school communities, all schools under the Schools Division of Quezon are hereby directed to disseminate and prominently display the official link and QR code of the **Quezon Learner Rights and Protection (LRP) Helpline** in conspicuous areas within the school premises.
2. The following are the guidelines for the dissemination of the QR code and link.
 - a. The official link and QR Code must be displayed in strategic locations such as:
 - School entrance and exit points
 - Bulletin boards
 - Guidance Office
 - Classrooms
 - b. Schools must ensure that the official link and QR Code are clear, legible, and accessible to all learners.
