LEARNER RIGHTS AND PROTECTION FOR CALENDAR YEAR 2026**

1. To ensure sustained and effective implementation of programs and interventions on learner protection, this Office, through the School Governance and Operations Division - Learner Rights and Protection (SGOD-LRP), requests all districts to update their designated **District School Head In-Charge of Learner Rights and Protection for Calendar Year 2026**.
2. All Public Schools District Supervisors (PSDSs) shall fill out the needed information about their designated coordinator through the link: <https://tinyurl.com/SHICLRP2026> on or before **February 6, 2026**.
3. The District School Head in-charge of the Learner Rights and Protection shall be responsible of the following:
 - a. Ensure the implementation of the technical assistance plan programs developed by the Division Office.
 - b. Closely coordinate with the Division LRP focal person in the conduct of LRP programs/activities.
 - c. Organize activities for the protection of children from abuse, exploitation, violence, discrimination, bullying, or peer abuse.
