#### FIRST PARTNERSHIP EDUCATION SUMMIT

- In reference to Republic Act 8525 also known as the Adopt a School Program of the Department of Education, the Schools Division of Quezon through the Schools Governance and Opertions Division Social Mobilization and Networking Section will conduct the First Partnership Education Summit on 25 March 2021, Thursday, 10:00 in the morning 2:00 in the afternoon at Sevilla's Farm and Resort, Domoit, Lucena City.
- The activity aims to presents the status and achievements of the Schools Division of Quezon and to give a broader idea on the Tax Incentive Provision stipulated in RA 8525 or the Adopta-School Act of 1998.
