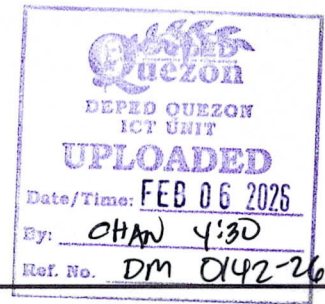

Pursuant to **DepEd Order No. 026, s. 2022**, titled Implementing Guidelines on the Establishment of School Governance Council (SGC), this Office, through the School Governance and Operations Division-School Management Monitoring and Evaluation (SGOD-SMME), is conducting a **Survey on the Compliance and Challenges of Public Secondary Schools on SGC Implementation**.
