2. **Technical officials and members of the technical working group are advised to report to the venue at the designated time. Upon fulfillment of their designated functions and the completion of their respective sports events, they shall immediately return to their respective stations.**
3. All teaching personnel shall provide support activities for the subjects taught in their respective schools to keep their students engaged. Likewise, school heads concerned shall take responsibility in assigning competent teachers/s to handle the affected classes in compliance with teacher-pupils/students contact time.
4. All teaching personnel who render services during weekends and holidays in connection with the 2026 Regional Athletic Association Meet shall be credited accordingly and shall be granted **service credits** in accordance with DO No. 53, s. 2003, while non-teaching, and teaching-related personnel shall receive **Compensatory Time Off (CTO)**, based on actual services rendered before and during the activity.
5. Expenses relative to this activity shall be charged against Provincial Special Education Fund (SEF), while other travel and incidental expenses shall be charged to their MOOE/local funds and other funding sources, depending on the availability of funds, in accordance with applicable accounting and auditing rules and regulations
6. Immediate dissemination and compliance to this Memorandum is desired.
