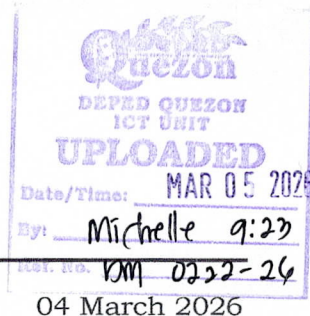

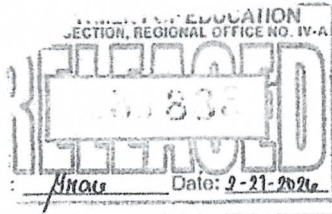

Application	Deadline of Submission
Permit to Operate New School, New Course Offering/ Grade Level	August 30, 2025
Renewal of Government Permit	January 02, 2026
Application of Government Recognition	February 01, 2026
Application for Changes in Tuition and Other School Fees	May 15, 2026

2. The Regional Office shall assess the completeness of the documentary requirements attached to the subject application. The applicant school shall be informed in writing of deficiencies noted if any, not later than the following month of the same year the said application was filed.
