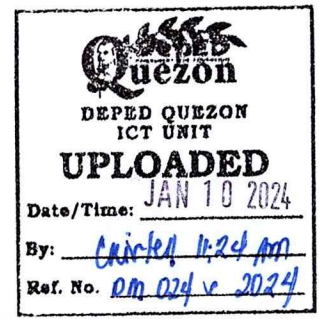

2024 Marching Lyre Band Competition General Guidelines

I. Eligibility

A. Competition is open to all existing lyre band in SDO Quezon from both public and private schools.

B. Age Bracket and Qualification

Elementary Category - The learner-participants should be nine (9) years old but not more than 12 years old during the date of the competition with at least satisfactory rating in all subject areas at present.

Secondary Category - The learner-participants should be twelve (12) years old but not more than 16 years old during the date of the competition with at least satisfactory rating in all subject areas at present.

C. Playing Members

Category	Non-Instrumental	Instrumentalists
Elementary	10-15	20-40
Secondary	10-15	20-40

II. Repertoire Requirements and Competition Stages

A. Elimination Round

1. Only one group per category will represent the municipality during congressional level competition.
2. The declared 1st place winner per category during the congressional level competitions shall compete and will represent the congressional district in the Division level lyre band competition.

B. Repertoire (Congressional Level)

1. Competing groups per category shall perform two (2) repertoires composed of **one (1) Filipino music** (Folk song or original Filipino compositions arranged or composed for lyre band) and **one (1) choice piece of preferred musical genre**.
2. Total playing time should not exceed 12 minutes including entrance and exits.

C. Repertoire (Division Level)

Competing groups per category shall perform two (2) musical pieces composed of one (1) choice piece performed in the congressional level and one (1) contest piece to be provided by the division organizing committee.

III. Performance Requirements and Parameters

1. Extravagant costumes are highly discouraged. Competing groups may use their old costumes or school uniforms if necessary.
2. The decision of the judges is final.
3. All competing groups shall adhere to the set guidelines of the competition. Failure to comply with the guidelines could be a ground for disqualification.
4. Schedule of rehearsals/practice/ trainings shall be strictly beyond class hours and weekends to ensure non-disruption of teaching and learning activities. Necessary permits and other legal documents must be secured during rehearsals.

IV. Criteria for Judging

Musicality (timbre, harmony, tone color, rhythm)	30%
Interpretation (interpretation, dynamics, synchronized movement)	20%
Mastery and Coordination	20%
Choreography/Exhibition	20%
Department	10%
TOTAL:	100%

1. The ranking system should be used in determining the winner.
2. Congressional winners shall be given trophies from the division while the cash prizes shall be within the discretion of the Congressional District through the host municipality.
3. Winners in the **Division Level** shall be given cash prize as follows:

First Prize	P30,000.00
Second Prize	P20,000.00
Third Prize	P10,000.00
Consolacion Prize	P 5,000.00
4. The date and venue of the Congressional Lyre Band Competition shall be during the respective Congressional Athletic Association Meet.
