

- g. Preferred additional requirements:
 - Remaining teacher applicants in the RQA, LET Passer, displaced private school teacher.
- Interested applicants should submit the following documentary requirements to the School Heads of the concerned schools:
 - Letter of intent addressed to the SDS, or to the highest human reource officer designated by the SDS;
 - b. Duly accomplished PDS Form (CS Form 212, Revised 2017);
 - Certified copy of the Voter's ID and/or any proof of residency as deemed acceptable;
 - d. NBI or Barangay Clearance;
 - e. Other documents as may be required such as but not limited to the following:
 - i. Photocopy of LET Eligibility/ Rating/ License ID, if there's any;
 - ii. Photocopy of Transcript of Records (TOR) and True Copy of Grades;
 - iii. Photocopy of Service Record or Certificate of Employment, if there's any;
 - Photocopy of Certificates of Training, if there's any;
 - v. Photocopy of the latest Performance Rating, if there's any; and
 - f. Omnibus certification of authenticity of the documents submitted, as eveidenced by the certification signed by the applicant.
- All interested applicants must follow the existing health protocols issued by the IATF-EID and DOH to avoid local transmission of COVID-19 disease.


