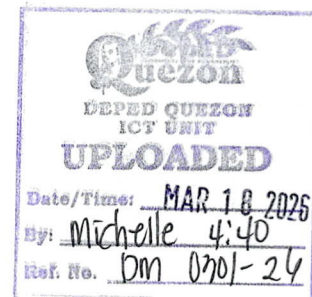

With reference to **Division Memorandum No. 284, s. 2026**, titled Schedule of the Distribution and Retrieval of the 2025 Accreditation and Equivalency (A&E) Test Materials, this Office informs all concerned that the **retrieval of test materials** shall be conducted at **Talipan National High School**, in lieu of the previously designated venue at the School Governance and Operations Division (SGOD) Office.
2. Attached also to this Memorandum is the **official list of testing personnel** for the administration of the 2025 A&E Test scheduled on **March 29, 2026**.
3. All designated testing personnel are hereby directed to **coordinate with their respective testing centers** to ensure readiness of logistical requirements and smooth conduct of the examination.
4. All **Chief Examiners** shall conduct a **pre-test orientation** for their assigned roving proctors, room examiners, and support staff prior to the scheduled examination to ensure clarity of roles, adherence to protocols, and proper administration procedures.
5. All other provisions stipulated in the previous Memorandum shall remain in effect.
6. In view of the conduct of the ocular inspection and site readiness activities on March 28, 2026 (Saturday), and the administration of the A&E Test on March 29, 2026 (Sunday), **all duly designated A&E Testing Personnel** who rendered actual service during the said activities shall be **entitled to corresponding service credits**, subject to existing Civil Service Commission (CSC) rules and DepEd policies on the grant of service credits for services rendered on weekends and non-working days.
