

DESIGNATION OF SCHOOL HEAD IN-CHARGE OF GOVERNANCE AND OPERATIONS (SHIGO)

To: OIC-Assistant Schools Division Superintendents

Division Chiefs

School Heads in-charge of Governance and Operations (SHiGOs)

All Others Concerned

- To streamline its operations and reporting systems, this Office through the School Governance and Operations Division (SGOD) designates a School Head in-charge of Governance and Operations (SHiGO) per schools district.
- 2. The SHiGO should perform the following responsibilities:
 - a. monitoring and evaluation of programs, activities and projects (PAPs) in the District, on areas of governance and operations only;
 - b. providing technical assistance to other schools in terms of governance and operations in coordination with the concerned SGOD section/unit;
 - c. collaborating with the School Management Monitoring and Evaluation (SMME) Section
 on the collection of data and reporting of SGOD-related programs during the conduct of
 Division Monitoring and Evaluation Plan Adjustment (DMEPA); and
 - d. accomplishing other governance and operations related tasks as may be assigned by the SDO through the SGOD.
- The SHiGO must be a full-fledged elementary or secondary school principal with notable performance in managing school operations as reflected in his/her Office Performance Commitment and Review Form (OPCRF).
- 4. A Messenger group chat will be created for SHiGOs to coordinate to school heads the submission of reports and dissemination of information related to governance and operations. On this regard, the Public Schools District Supervisors are requested to inform their respective
